Kind attention is invited to the public notices issued by AIIMS Bibinagar on several instances earlier with regard to the misuse of the name of the Institute and authorities of Institute for fraudulent activities cited at references above. It is again heard from verified sources that some miscreants are collecting money and favours from local public and job aspirants promising offer of appointments in AIIMS Bibinagar. This is a matter of grave concern and AIIMS Bibinagar views it with utmost seriousness.

With regard to the above, it may kindly be noted that all appointment in AIIMS Bibinagar both regular and contractual happens only through transparent processes purely based on the merit and there is no other channel of appointment whether through any agency or people. AIIMS Bibinagar had not entrusted any agency or person for any sort of appointment whether regular or contractual. All regular, deputation and consultancy/contractual vacancies in AIIMS Bibinagar are duly advertised in the employment news and daily newspapers etc. as well as uploaded in the institute website at <https://aiimsbibinagar.edu.in/>. Some senior positions are also published by the Ministry of Health and Family Welfare in the PMSSY website at <https://pmssy.mohfw.gov.in/>. All the regular, deputation and consultancy/contractual positions are filled strictly based on the terms and conditions mentioned in the notification. **We appeal to the general public and aspirants not to trust any source, agency, or individuals other than the above.**

Further, it may also be noted that engagement of manpower on outsourcing basis are done through the manpower agencies that are awarded manpower or services contract through a competitive online tendering process online on Govt e-Marketplace (GEM) or Central Public Procurement Portal (CPPP). Engagement of outsourcing manpower strictly lies within the purview of the Contractor/Manpower agencies to which the contract is awarded by following the due procedure. AIIMS Bibinagar has no direct role in the appointment of the outsourcing manpower other than assessing the suitability of the manpower provided by the agency (employer) for the defined set of responsibilities, skills and qualification required for the role.

Corruption of any sort is a menace and hindrance to the national development. We as responsible citizens are duty bound to keep vigilance against these menaces and make our society and country corruption free. AIIMS Bibinagar is sincerely concerned about the individuals (if any) who are misled by these miscreants by misusing the name of the Institute or its authorities. We are steadfast on taking strict action against those engaged in such criminal offences by misusing the name of the Institute and thus defaming the reputation of an Institution of National Importance as AIIMS Bibinagar that stands in service to the public, society and the Nation.

**We sincerely appeal to the local public, job aspirants and all well-wishers to be vigilant and not fall prey to the trap of such frauds and miscreants. We also appeal to all the employees, outsourced staff and stakeholders of the Institute to cooperate and support the Institute authorities to uproot and eradicate such menace.**

Further we also appeal to all, to immediately bring any such incident noticed to the attention of AIIMS Bibinagar authorities as mentioned below and the local SHO, Bibinagar Police Station along with the evidences, for strict and exemplary action on such social miscreants. All efforts will be taken to keep the identity of the informants confidential.
