All applicants with Persons with Benchmark Disabilities (PwBD) who are appearing for Computer Based Test (CBT) for various recruitment posts of Group 'A', 'B', 'C' are hereby informed that they may request for a scribe if they belong to the categories of **blindness, locomotor disability (both arm affected - BA) and cerebral palsy**. Such applicants are required to submit a Letter of Undertaking for Using Own Scribe (APPENDIX-II). For other categories of PwBD as defined under section 2(r) of the RPWD Act, 2016, the facility of scribe is permitted on the condition that the candidate presents a certificate certifying that they have a physical limitation to appear for the CBT, using the prescribed proforma (Certificate regarding physical limitation in an examinee to write - APPENDIX-I)

**Note.(i)** If desired, kindly submit a Letter of Undertaking for Using Own Scribe (APPENDIX-II) and Certificate regarding physical limitation in an examinee to write - APPENDIX-I) **by 05<sup>th</sup> May-2023, 5.00PM undersigned at E-mail id: [helpexamcell.aiimsbibinagar@gmail.com](mailto:helpexamcell.aiimsbibinagar@gmail.com) only. (Copy enclosed)**

**(ii).** And also carry the original undertaking letter along with Admit card to CBT Examination centre.

## FREQUENTLY ASKED QUESTIONS FOR PERSONS WITH BENCHMARK DISABILITIES (PwBD) CANDIDATES

### Q.1 Who can opt for the facility of scribe?

A. The Persons with Benchmark Disabilities (PwBD) in the categories of blindness, locomotor disability (both arm affected – BA) and cerebral palsy are provided the facility of scribe, if desired by the person. In case of other category of Persons with Benchmark Disabilities as defined under section 2(r) of the RPWD Act, 2016, the facility of scribe is allowed to such candidates on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on behalf, from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Government Health Care institution in the prescribed proforma (Certificate regarding physical limitation in an examinee to write (APPENDIX- I)

### Q.2. Will the AIIMS Bibinagar provide scribe to the candidates or the candidates have to bring their own scribe?

A. No, Candidates requiring help of a Scribe should themselves bring their scribe. Institute will bear no expenses for the purpose while using help of a scribe.

### Q.3. Is there any prescribed qualification for the scribe?

A. The qualification of the own scribe should not be more than the minimum qualification criteria of the Examination . However, the qualification of the scribe should always be matriculate or above.

### Q.4. If any non-PwBD candidate unfortunately fractures or injures his/her writing hand before the Examination, will he/ she get the facility of scribe?

A. There is no such provision in the Rules of Examinations. It is reiterated that only the candidates having specific disability and having the valid disability certificate as per prevailing rules are eligible for scribe.

### Q.4. Who is eligible to get the Compensatory Time and what is the quantum of the Compensatory Time?

A. The PwBD candidates in the category of blindness, locomotor disability (both arms affected- BA) and cerebral palsy are allowed Compensatory Time of twenty minutes per hour of the examination. In case of other PwBD categories, this facility is provided on production of a certificate to the effect that the person concerned has physical limitation to write from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government Health Care institution as per the prescribed proforma.
